Office of the Superintendent of Motor Vehicles Adjudicators Procedures Manual as amended on September 20, 2010 and all amendments to [November 19, 2013]; [Specified] documents relating to Wilson V. British Columbia.

Please find enclosed phase three, the final phase, of your request. Some information has been withheld in the enclosed records pursuant to sections 15 (Harm to law enforcement) and 22 (Disclosure harmful to personal privacy) of FOIPPA. The Office of the Superintendent of Motor Vehicles Adjudicator Procedures Manual is available on the Province of British Columbia Open Information website. JAG-2013-01069 contains records specific to quality control standards for Adjudicator Decisions and JAG-2012-02390 contains records of manuals, documents, policies, directives and procedures pertaining to the steps taken when an Immediate Roadside Prohibition is revoked.
