Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety. As per the decision to withhold the names and title of the MOUs in your previous request JAG-2013- 01624 pursuant to section 15 of FoIPPA, this information has not been provided in the attached records. The ministry wishes to advise that items identified by green-filled lines represent records which the ministry has physical custody of and items identified by pink-filled lines are agreements not in the physical custody of the ministry. Your file is now closed.
