The Ministry of Finance (MFIN) collects debt on behalf of various client ministries; debt is referred to MFIN via a Collection Intake Form. MFIN is responsible for collection of the debt, pursuant to the *Financial Administration Act*, as well as sections 7.2.21 and 7.2.22 of the Core Policy and
