I am writing further to your request received by Road Safety BC, Ministry of Justice (previously Office of the Superintendent of Motor Vehicles). Your request is for:

The total number of Immediate Roadside Prohibitions issued in the month of December, 2014; Copies of every IRP decision from the month of December 2014 in which the prohibition was revoked.

Immediate Roadside Prohibitions (IRPs) are issued by Municipal Police or RCMP. The total number of IRPs processed by Road Safety BC in the month of December 2014 is 1,663. The number of IRP reviews conducted in the same month by Road Safety BC is 345. The total number of IRPs overturned, as represented by the enclosed records, is 83.
