

## **Review of Partnerships BC – Selection of Stakeholders**

The FOI request is for “documentation showing how these stakeholders were chosen”.

For government, stakeholders from the key capital ministries were selected (Health, Education, Advanced Education and Transportation and Infrastructure) with additional stakeholders in two of the health authorities and one school district. Both executive and staff level employees were interviewed.

Stakeholders from Ministry of Finance working with Partnerships BC and/or key capital ministries were also interviewed – this included executive and staff from Treasury Board Staff, Provincial Treasury, Risk Management Branch and the Crown Agencies Resource Office.

Stakeholders from industry were interviewed with representatives from the British Columbia Construction Association, Vancouver Island Construction Association and the Independent Contractors and Business Association.
