This correspondence is to confirm some changes to the terms of employment that were included in your October 29, 2013 appointment letter as the BC Trade and Investment Commissioner. The specific amendments are as follows:

- The appointment letter provides for "five round trip air tickets per year for personal use". The value of a flexible round trip ticket between Beijing and your home s22 has been nominally assessed at \$3000. The five trip limitation at the economy class airfare has since been deemed restrictive. You are therefore authorized to claim up to a maximum of \$15,000 per year for documented personal travel for you and your spouse. While this does not provide for an enhanced benefit beyond the original terms of employment, it does provide you with greater flexibility. The \$15,000 maximum is exclusive of the exploratory trip noted in your appointment letter.
- It has become evident the \$5,000 per month living expense budget is prohibitive for a furnished apartment in the Central Business District of Beijing. You are therefore authorized for documented living expenses to a maximum of \$7,500 per month to secure suitable accommodation and services.

BACKGROUND REGARDING THE ISSUE:

Oct. 28, 2013

VANCOUVER - Premier Christy Clark is appointing an investment and trade commissioner to promote and advance British Columbia's trade and economic interests and strengthen the Province's government-to-government relationships in Asia.

"This is a crucial time in our trade relations with Asia and we want to strengthen the ties that attract new investment to British Columbia," said Premier Clark. "The appointment of Ben Stewart sends an important signal to these markets - we want to be your partner in business. That is why we are stepping up our game, increasing our government's presence in Asia and making clear this is a priority for us."

The investment and trade commissioner will represent and promote British Columbia in meetings with government officials in our priority markets in Asia, including hosting and acting as an official signatory for the Province.

- Represent and promote the Province of British Columbia at events and activities to advance the Asia Pacific Trade and Investment Strategy and government trade priorities.

• Lead the negotiation and/or development of partnerships, protocols, Memorandums of Understanding and/or agreements with other governments, agencies and institutions, including acting as official signatory for the Province of British Columbia where required.

5. Accountability

- The Commissioner will report directly to the Minister of International Trade and Premier.
- The Minister of International Trade will designate responsibility for day to day operational issues to the Deputy Minister of International Trade.

6. Support

- Budget, including travel, hosting, gifting, office support will be researched and assessed
- Need for official office space in Beijing will be researched and assessed
- Other operational support can be provided through Ministry headquarters

7. Reporting, Outcomes and Review

- Commissioner will track key activities, meetings and outcomes in the Ministry's Salesforce CRM system
- Commissioner will develop key performance metrics in consultation with the Ministry of International Trade and in line with Ministry performance metrics
- The Minister of International Trade will review the performance of the Commissioner annually to ensure performance objectives are achieved, and provide updates on activities and results.
