Merima, your last correspondence dated July 16/2012 indicated the proponents (Westbank First Nation and Canadian Aggregates Inc) had accepted your offer (10 year Licence of Occupation), but had outstanding requirements to satisfy before a tenure could be issued, for:

- Submission of final management plan;
- Baseline contour survey; and
- Fees, security and insurance.

Please advise if the status changes. This was identified as a priority for us, but MEM won't be issuing a Mines Act Permit until all pre-requisites for the Licence of Occupation have been satisfied and Licence of Occupation has been issued.
