## Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

A copy of all records from the Ministry as well as its road maintenance service provider related to the investigation, documentation and recording of a three motor vehicle collision event occurring on November 26, 2010 at or near Highway 99 south of Porteau Road between Horseshoe Bay and Squamish BC, including a copy of all road maintenance records related road maintenance service provided to the area of the site of the collision event for the 24 hour period preceding the collision.
