- Thank you Barry, it's a pleasure to be here.
- Thank you for inviting me to share in the 10th anniversary of the Integrated Cadastral Information Society (ICIS).
- Ten years is indeed a milestone worthy of celebration.
- I'd like to take this opportunity to offer my congratulations to the Board of Directors, staff and all the members.

- I'd also like to compliment you on your theme today "The Future of Collaboration" – it's very timely and speaks to what the Province is working hard to achieve.
- As you know, the Province has a long standing relationship with ICIS, spanning 10 years... as a founding partner, member and data integrator.
- So it's with hope that I speak about open data and opportunities where we can build on our past collaboration to create new opportunities and success.

Accomplishments

- When it comes to open government and open data, there's a lot to talk about.
- Open government was a platform commitment for Premier Clark and is a major priority for our Premier, myself and in fact all of government.
- Over the past year, the Province has done a number of things to put open government front and centre.
- In March, Premier Clark created the ministry I'm responsible for – Labour, Citizens' Services and Open Government – to reflect this priority and

make sure we are focusing on open government.

- This summer, the Premier issued a direction to every ministry to make data and information available to citizens on an ongoing basis. This supports greater government transparency, engagement with citizens and economic development.
- We established a policy to provide guidance to each ministry about how to open up their data and information holdings.
- The policy also helps ensure our obligations to privacy, security,

intellectual property and existing policy or contracts.

- Together, the policy and direction helped set the vision and tone for us to begin data sharing both across government and with the public.
- We've launched a new open data site called DataBC.
- DataBC brings together nearly 2,500
 datasets that were previously spread out
 all over government, some of which
 were hard to find or interpret.

- We've made the data searchable and accessible to people, presenting it all in machine readable formats.
- Citizens can now access a diverse range of data, everything from financials to education test results and environment data – all from the same website.
- These datasets are available under an open government license that encourages people to use the data.
- The license itself is the product of collaboration; the United Kingdom happily agreed when we asked if we could adapt their open government license.

- As a result, people are free to copy, publish and distribute the Province's data, adapt it to suit their needs and even use it for commercial purposes.
- Opening up government data and information is a real shift for government and it has huge implications.
- It allows citizens to gain a better understanding of issues or help create solutions ... and it allows us to take advantage of the knowledge and expertise of the public as well.
- Expanding access to data and information also gives students more resources to learn from. For example, students now have greater access to

information about education, scholarship or loan information.

- As I'm sure you know, data sharing unlocks enormous potential for innovation.
- Along with DataBC, we also launched an Open Information website. This is where we're posting freedom-of-information requests and responses, and monthly expenses for cabinet ministers and deputy ministers.
- Underpinning our efforts is the commitment to change how we interact with citizens.

- So far, we've received a wide range of positive feedback about what we're doing, from open government advocates like David Eaves, B.C.'s Information and Privacy Commissioner Elizabeth Denham and even some of our sharpest media critics.

- The feedback we've received has been encouraging because it reinforces that we've on the right path.

Next Steps

- Open data is a new era for us and it's really exciting to be at the forefront. B.C. is the first province in Canada to offer truly open information and data.
- ... and this is only the beginning.
- As part of our transformation and technology planning, ministries have been asked to inventory their data holdings and then prioritize for public release.
- Building a passionate user community is important as well.

- The Province partnered with the Mozilla Foundation and OpenDataBC to host its first ever hackathon last month... and we're looking forward to do more events like this.
- Right now, we're bringing together a group of people who can help us use open data to continue to foster a more open government.
- We're reaching out to people who are major data users from the private sector, universities and non-profits to work collaboratively with us on the challenges and opportunities of open data.
- We are also putting in place the program governance required to ensure that DataBC is successful.

- Also, we're developing tools for DataBC suppliers to allow them to add and manage their own content and monitor user feedback.
- We're also actively managing requests for data from the user community.
- For example, there's a strong interest in access to:
 - Land ownership data
 - Public safety data
 - Property assessment data
- There are many opportunities to collaborate, share best practices and lessons learned.

- ...One of the reasons I came to speak with you today is because I believe there's a significant opportunity for the Province and ICIS partners to collaborate and open access to data.
- Projects such as the Integrated
 Cadastral Fabric and the AddressBC database add tremendous value to our province and our service delivery.
- I'd like to challenge the board of directors and members to make your data more freely available – not just to members – but under an open license.

 By providing open data, a barrier is removed and innovation can begin.
 People use data in meaningful and informative ways and it can make a difference in their lives.

Closing

- Once again, I'd like to congratulate you on the 10th anniversary of the Society.
- This is an exciting time to be working in the field of open government. This subject is in its infancy and there's a lot we can learn from each other.
- Let's empower people to create value from open data and improve citizen interaction with all levels of government -

- …laying the foundation of collaboration.

- Thanks for having me on today.
- I'm Stephanie Cadieux, Minister of Labour, Citizens' Services and Open Government it's a pleasure to be here today to chat about what the ministry I'm responsible for is all about.
- Open government is the wave of the future here in B.C., it was a platform commitment for Premier Christy Clark and is a major priority for our Premier, myself and in fact all of government.
- With me is Herb Lainchbury who is one of the founders of OpenDataBC. Herb will be helping facilitate the Province's first ever hackathon on August 27th, which we'll talk about later in the show.
- Herb does a lot of inspiring work with the open data community in our province. He using
 information technology to make more information easier to use for people like myself and
 your listeners.
- The values and vision of OpenDataBC and the work Herb does are the same as what we're doing with open government in B.C.
- In March, Premier Clark announced her cabinet and created the ministry I'm responsible for

 Labour, Citizens' Services and Open Government to reflect this priority and make sure
 we are focusing on open government.
- It's a broad term in essence, open government is about the spirit of collaboration, innovation and partnership. It means sharing information, being more transparent and engaging with citizens in new ways.
- We want to hear directly from people like your listeners and we want British Columbians to know that we're listening. We are taking their concerns and advice and acting on it.
- We're working hard to change the style and approach of government and I'm proud of the accomplishments we've had already.

Open Government Accomplishments

• Led by Premier Clark, we are holding monthly town halls to talk directly with British Columbians all around the province on issues that impact them.

For example, more than a quarter million British Columbians across the province
participated in 11 telephone-town hall meetings about the HST. While people asked a lot of
questions about the HST, they also told us they want more open, two-way communication
with their government.

- DataBC brings together about 2,500 data sets that were previously spread out all over government, some of which were very hard to interpret.
- This is a central place for you to access and a place for us to share raw data and datasets that the provincial government collects.
- The creation of DataBC is part of our commitment to be an open, transparent and accountable government.

 We are also to post freedom-of-information requests and responses online, at Open Information, <u>www.openinfo.gov.bc.ca</u>. You can now go online to view monthly expenses for cabinet ministers and deputy ministers.

Web Presence

- We have redesigned government's front door at gov.bc.ca. As a result of direct consultation with citizens, this new site is designed to be service oriented and focused on your needs.
- This website will save you time. Studies show that timeliness is the single most important
 driver across all services and all governments, and our new website is designed to be more
 intuitive so you can find what you need quickly and easily.
- You can now go to B.C.'s government homepage and easily find the most popular services –
 the kinds people most often need to use. For example, links to apply for medical coverage or
 to get help with the cost of prescriptions or to search for jobs.
- We wanted to make it easier for you to contact government, to find the right forms, to learn about government programs – essentially to find the information that's important to you – without having to search through different government ministries trying to guess where things are.
- We have made it friendly for all kinds of devices, like tablets and smart phones, and we'll be working continuously to improve accessibility no matter what the device.

DataBC

- B.C. is the first provincial government to create a site like DataBC, a catalogue of data that is free, searchable and available for anyone to use.
- We currently have nearly 2,500 sets of data available through DataBC for you to try your hands at and do something creative with.
- More datasets will be added as they become available, and in fact we've already added 26 new entries to the catalogue since launch last month.
- For the first time, the Province has adopted an open-data licence that makes information available freely and flexibly, with only a few conditions. This means you – or anyone else – can copy, publish and distribute the information, adapting the information to suit your needs and even use it for commercial purposes.

- Government data really does belong to everyone. By making it publicly available, we're
 unlocking enormous potential to enhance democracy, citizen participation,
 entrepreneurship and public dialogue.
- The most popular datasets being used right now are:
 - Current Grade 10 science results at B.C. high schools
 - Geology fault lines for British Columbia
 - o Records of known obstacles to fish passage
- Innovators and researchers who use DataBC may be able to tell us how well our hospitals and schools are performing and what neighbourhoods best suit our lifestyle.
 - The data can help students predict what jobs will be in demand in the future, and help employers understand where there will be shortages in skilled workers they need.
 - The data shows standardized test results across the province, school district by school district, school by school. It can help parents have more informed conversations with their classroom teachers and principals on their student's achievement levels.
 - This data can be used to challenge the status quo and to improve it.
- We will be working with a group of leaders from the technology community who can help us transform this data into information that can make a difference in people's lives.
- I know that opening up government data for everyone will result in challenges to the ways that we have been doing things. It may expose weaknesses in our systems and our institutions. But just as likely it may also lead to innovative solutions.

Hackathon

- I'm pleased to announce the Province is partnering with the Mozilla Foundation and OpenDataBC in Vancouver to host our first ever hackathon on Saturday, August 27.
- Open government is about the spirit of collaboration, innovation and partnership, so it's in this spirit that we're hosting our first ever hackathon.
- By bringing some of the brightest minds together, we hope to see how the creative use of public data can answer questions, identify problems or help create solutions.

- We will be bringing together people who are all major users of public data, from the private sector, universities and non-profits.
- It will be an opportunity for people to work with data, mash different datasets together to gain a better understanding of issues or to help create solutions and people can bring ideas for what to do.
- The Mozilla Foundation and OpenDataBC are both non-profit organizations that promote openness, innovation and participation on the Internet. So it's a natural fit for us to partner with these organizations to help foster collaboration and innovation in B.C.
- Anyone who's interested in learning how the creative use of public data can answer
 questions or help create solutions to problems is welcome to bring a laptop and come on
 down.
- This will be an engaging way to show off the Province's new open data site, DataBC and how its 2,500 datasets can be used in creative and interesting ways.

Open Information - FOIs and Proactive release

- Public information released through Freedom of Information is posted to B.C.'s <u>Open</u>
 <u>Information website</u> a minimum of 72 hours for electronic records and a minimum of five days for mailed copies after being released to the applicant.
- The website is fully searchable and updated regularly, as frequently as daily, as new FOI
 requests are released.
- This approach is supported by B.C.'s Information and Privacy Commissioner and in fact goes further than the Commissioner's recommendations and meets the interests of FOI applicants and the public. This gives the requestor value for the information they've asked and paid for.
- As well, Ministers' and Deputy Ministers' travel expenses are now published monthly.
- Our Open Information site is an integral part of our commitment to be an open and accountable government. We are making frequently requested government information accessible to the public without them having to make a formal request for information.
