Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Transportation and Infrastructure. Your request is for:

The following records regarding a collision that occurred in the intersection of Highway 97 and Dilworth Drive, Kelowna, BC: Engineered drawings of the intersection as it existed on October 26, 2016; The timing of the traffic light sequence between 6:45 pm and 7:15 pm on October 26, 2016 - if the timing of the traffic light sequence changed during that time frame, then please ensure the records indicate when it changed: Traffic camera recordings at this intersection as of October 26, 2016, between 6:45 pm and 7:15 pm.

Please find enclosed a copy of the records located in response to your request. Our responsive records include engineering drawings of the intersection of Highway 97 and Dilworth, as existed on October 26, 2016. These records are provided to you in their entirety.

Regarding the timing of the traffic light sequence, please note that this information is routinely releasable by the Ministry. You may follow up on this aspect of your request with ministry contact Graeme Cross, Senior Traffic Operations Engineer (Graeme.cross@gov.bc.ca; 604-527-2263).

Regarding traffic recordings at this intersection, the cameras take still images every 15 minutes; these images are overwritten after two weeks and are therefore unobtainable in this case.
