A copy of the records gathered and released as TRA-08-201, dealing with the North Shore Road aka Youbou Road on the north shore of Lake Cowichan - part of the road runs through Lake Cowichan Indian Reserve Number 1, including any additional headquarter and district records that concern the road on the reserve from the end of the period covered by TRA-08-201 until the present day. (Date Range for Record Search: From 01/01/2008 To 09/10/2019)
