*All records including but not limited to reports, plans, documents, correspondence, notes, inspection records, records of discussions, data, maps, and receipts relating to all previous, existing or proposed bridge crossings over the Cheekye River in the District of Squamish at or near Fernwood Road, Moose Road and/or the Squamish Pemberton Trail. (Date Range for Record Search: From 01/01/1976 To 10/20/2016)*
