### Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Public Safety and Solicitor General. Your request is for:

The number of impaired driving infractions from cannabis consumption and alcohol consumption for October 17, 2018 to April 17, 2019; All records, reports, etc. relating to impaired driving infractions based on cannabis and/or alcohol consumption from October 17, 2018 to June 4, 2019.

Please find enclosed a copy of additional records located in response to your request. These records are provided to you in their entirety. The enclosed reports originate from the BC Prosecution Service (BCPS). To assist you in the interpretation of information found in the reports, BCPS provided the following footnotes:

#### RCCs:

- The year / month is based on the date the Report to Crown Counsel (RCC) was first entered into JUSTIN
- Includes BCPS files only (Federal files excluded)
- One RCC will name one or more accused persons, alleging one or more charges (counts) per person. The RCC measure counts only RCCs where the "most serious offence" on the RCC is one of the driving offences found on the report.

#### Approved to Court:

- Crown charge assessments are counted in relation to each accused person named on the RCC. This report counts the number of accused where the most serious offence on the RCC is one of the listed driving charges, however, the accused may be approved to court on a different count (charge) on the RCC and not necessarily the driving offence.

Concluded:

- Each prosecution is considered to be concluded when a final court decision has been reached.

- This report counts the concluded prosecutions where the most serious offence going into court was one of the driving charges on the report.

Guilty and Guilty to a Lesser findings:

- Is a count of concluded files where the most serious offence (MSO) going into court was one of the driving charges on the report and the finding on the file was "Guilty" or "Guilty to a Lesser, Included."
- The finding on the conclusion tells us that a Guilty was found on at least one of the counts on the file. The guilty finding may or may not be on the MSO going into court.
- Guilty to a Lesser, Included (GLI) finding is a count of concluded files where the most serious offence going into court was one of the driving charges on the report and the accused was found guilty to a lesser offence. The GLI may or may not have been the finding on the MSO going into court.

Your file is now closed.
