A summary document listing all societies who have received the written consent of the director under section 2.1(a) of the Society Act, regarding “the operation of a boarding home, orphanage or other institution for minors, or the supplying of any other form of care for minors.”; A summary document listing all companies, societies, corporations, agencies, or other organizations who have received contracts to provide residential services to children and youth under the age of majority, along with the amounts awarded, and the number of children expected to be served, for the 2014/15 fiscal year.
