Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Children and Family Development. Your request is for:

Yearly totals (2010-2018): For the number of Continuing Custody Order applications by BC's Ministry of Children and Family Development; For CCO applications that proceed to protection hearings broken down by regions or Service Delivery Areas; For the number of CCO applications that are granted broken down by region, and the number of applications pertaining to Indigenous children; For each year in the range, according to MCFD's internal audits, what is the compliance rate for starting protection hearings within 45 days after the conclusion of the presentation hearing (CFCSA Section 37). (Date Range for Record Search: From 01/01/2010 To 05/29/2018)

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety.

Please note that information for the remainder of your request is not being provided as it goes beyond the Ministry's duty to assist as per section 6 (2)(b)of FOIPPA.

The Ministry has provided the following explanation:

Most of the data is held by the courts, not by the Ministry of Children and Family Development (MCFD) and, therefore, not captured in our systems. Specifically we are unable to count hearings/applicants because that data is held with family court and would quite possibly require a manual count. If we were to provide a manual count this would be via a contract to ad hoc (LSB) counsel and would incur significant legal costs as it is outside of a contract counsel billing or funding. For the Continuing Custody Order (CCO) applications that proceed to protection hearings broken down by Service Delivery Area (SDA), this would require manual review of all MCFD files within the time frame; identifying which ones went to CCO, and, of those, which ones went to CCO because of a protection hearing. This data is not readily available and would require creating new data based on numerous other files.
