Any document listing all considered and shortlisted child-care sites in B.C. before the final group was selected for the universal child care prototype sites program currently underway. As well, any assessments of shortlisted child care sites considered citing reasons for and against implementing the program in each site. Narrowed to Burnaby and New Westminster sites. (Date Range for Record Search: From 01/01/2018 To 11/01/2018)

Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to section(s) 13 (Policy advice or recommendations), and 17 (Disclosure harmful to the financial or economic interests of a public body) of FOIPPA.

Scoring sheets were removed as they contain harmful business information about their practices, and would provide insight in to specific scoring which may provide an advantage to future candidates.
