All records in the message tracking log files (files beginning with MSGTRK in %ExchangeInstallPath%TransportRoles\Log\MessageTracking) from the Microsoft Exchange services maintained by the Ministry of Technology, Innovation, and Citizens' Services, where the record is from Minister Finance Michael de Jong, including any and all email addresses used. This record should include the sender ID, receiver ID, date and time, and email subject, if possible. (Date Range for Record Search: From 02/01/2016 To 02/08/2016)

Minister de Jong sent no emails during this time period as the minister does not conduct government business by email.
