## Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Citizens' Services. You provided information to narrow your request on June 18, 2019 through conversation and/or email with Toyoko Doyle. Your request is for:

[Specified] records regarding the demand for S.I.N.s and the Speculation and Vacancy Tax Declaration. (Date Range for Record Search: From 06/01/2017 To 03/25/2019)

Specific Records Requested (revised):

- 1. all briefing notes to the Deputy Minister of Finance regarding the demand for respondents' social insurance number on the Speculation and Vacancy Tax Declaration (2019)
- 2. most recent complete risk assessment prepared by or for, and relied upon by the Ministry of Finance regarding the demand for S.I.N.s
- 3. the document that sets out the rationale for not including paper filings to BC Ministry of Finance office through the standard property tax collection system
- 4. all records demonstrating that BC's use of the S.I.N. for the Speculation and Vacancy Tax Declarations and for determining exemption from that tax complies with the purposes, restrictions and security requirements for the use of S.I.N.s
- 5. the contract between Service BC and Maximus corporation for call centre services associated with the collection of the Declarations by telephone

- a. alternatively, records outlining all terms and conditions, and measures implemented to ensure the security of the personal information provided by British Columbians to Maximus employees contracted to Service BC for this function
- 6. the records setting out the measures taken to ensure the security of personal information, including the S.I.N. and other financial information, collected by Maximus corporation under the contract for collection of Speculation and Vacancy Tax declarations.
- records that identify the ownership and geographic location of the servers used to receive, process and store the data collected through the Speculation and Vacancy Tax Declaration (2019) filings (by phone and online)
- 8. the risk assessment related to the potential application of the US Patriot Act to Maximus, including the risk of a foreign government gaining access to the Declaration data received, processed or stored by Maximus or Service BC
- 9. all approved communications materials to be used by Government of BC employees in response to concerns regarding the requirement to submit the S.I.N. or any other concerns regarding security of personal information collected through the process established for this tax declaration by the Administrator.

## Information you provided to narrow the request:

"I am only interested in the final versions of the relevant documents, not the various drafts. The records I am seeking would take the form of briefing notes to Ministers or Deputy Ministers, risk assessments prepared by policy analysts and operations specialists, specified contract(s) or relevant portions of those contracts, and operational flow charts or the step-by-step instructions prepared for front-line staff. I am not seeking the email exchanges between individuals in the preparation of these materials.

The focus of this request is on the demand for property owners' Social Insurance Numbers in the Speculation and Vacancy Tax declarations, which necessarily limits the time period to a date following the election of the current provincial government - which is less than two years. "
