I am writing further to your request received by the Ministry of Education. You narrowed your request on January 26, 2016 through email with Lise Mino to exclude any records that contain personal information that would otherwise be withheld under s. 22. Your request is for:

Records, including reports, memos, briefing notes, correspondences, etc. prepared in anticipation of and in response to 2015 stories in the Toronto Star about concerns and complaints about sports coaching policies and practices at St. Michael's University School in Victoria - e.g., "Teachers' bullying scarred us, say student athletes," by Rob Cribb (March 14, 2015), and "Teacher sues prestigious B.C. school alleging bullying, harassment" (April 02, 2015). Also notes on "Allegations of verbal abuse by SMUS coaches unfounded, school says, by Amy Smart, Times Colonist, March 16, 2015.
