### APPENDIX A

Request: Copies of all invoices related to any external services, products, consultants etc. related to educational programming for bullying prevention being provided to schools within BC.

### ERASE language:

The ERASE (Expect Respect and a Safe Education) strategy is a comprehensive prevention and intervention strategy focused on addressing bullying and student safety matters in schools. ERASE is about providing a safe school environment for our students, and ensuring school districts have consistent approaches to addressing bullying and harmful behaviours and to do this a comprehensive training program for educators and community partners was developed in October 2012.

There are four levels of training offered within the ERASE strategy with Level 1 focusing specifically on training educators on bullying prevention in schools.

## Level 1 - Preventing Bullying & Ensuring Safe and Caring School Communities

Level 1 training strives to provide a deep understanding of how to create, measure and evaluate school connectedness and expands into exploring the different climate and culture of classrooms and schools. A main focus is on the prevention of bullying and on intervention techniques. This one-day training builds on the current level of baseline knowledge and capacity of professionals in British Columbia in relation to our students' use of digital devices, the Internet, and social media. The training also focuses on current trends of youth behaviour online as well as the negative use of such platforms to engage in cyberbullying, capping, sextortion, and related legal ramifications that apply to the negative behaviour exhibited

#### Level 2 - Basic Threat Risk Assessment

Level 2 training will helps participants gain a thorough understanding of the theoretical framework for Violence Threat Risk Assessment (VTRA) and focuses on:

- Understanding the difference between Stages 1, 2 and 3 of the VTRA process
- Awareness of recent high profile incidents where religiosity and radicalization impact the VTRA process

#### Level 3 Training - Advanced Threat Risk Assessment

Level 3 training includes a focuses on:

- VTRA protocols
- Critical Incident Response plans

- Child and Youth Mental Health
- Inventory of Services
- Specific case studies
- Advanced social media data collection

#### <u>Level 4 – Train the Trainer</u>

Level 4 - Train the Trainer has been broken down into smaller modules that focus on core content delivered in Levels 1 and 2. Trainers will be able to use the modules in delivering customized learning sessions to other school/district staff and community partners to broaden the awareness of the core content covered in the ERASE Strategy. The intent of the Level 4 – Train the Trainer is not designed to have trainers replace the current Level 2 – 2 Day Basic VTRA or the Level 3 – 2 day Advanced VTRA.
