I am writing further to your request received by the Ministry of Education. Your request is for:

The following records in machine-readable format, preferably the original excel spreadsheet: A similar table to Table B Classroom Enhancement Fund for the numbers mentioned in the 2017 news release, which is probably the number for 2016-17 – specifically, requesting the final updated table for 2016-17 giving the data for each school district and the provincial total, and including these columns - FTE, Staffing Cost, Overhead Cost, Annual Remedies, Revised Classroom Enhancement Fund Allocations, Unused Priority Measures, Recoveries Based on Reported Underspend, and Classroom Enhancement Fund Grant; The number of staff hired by the Classroom Enhancement Fund, or similar fund from the restoration of contract language following the 2016 Supreme Court of Canada decision if it wasn't called Classroom Enhancement Fund, broken down into the staffing types and programs recorded by Form 1530, as mentioned above - provide this data for both the 2016-17 and 2017-18 school years.
