Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by Emergency Management BC. Your request is for:

Copies of all documents, including scene photographs, in relation to various entities' investigations into a structure fire that occurred on December 19, 2009 at the NT Air Hanger located at 4245 Hangar Rd, Prince George, BC V2N 4M6 and any search for the remains of [named individual] from December, 2009 to present – including but not limited to the grid search of the area surrounding the NT Air Hangar in and around June of 2010 conducted by the Prince George Search & Rescue organization. Records from the latter entity have apparently been turned over to the Prince George RCMP and Emergency Management of BC. (Date Range for Record Search: From 12/19/2009 To 3/16/2020)

The records located in response to your request will be delivered through the BC Secure File Transfer Service. Separate emails will follow from the BC SFT Notification Service directing you how to set up an account and where to obtain your records.
