Any e-mails including any attachments or other correspondence between federal government representatives and BC government representatives relating to efforts to protect Southern Mountain Caribou and their habitat in the Southern Mountain Ecological Area - SMEA; Any agendas produced for and minutes produced from meetings between federal government representatives and BC government representatives relating to efforts to protect Southern Mountain Caribou and their habitat in the SMEA, and any documents relating to or produced for or discussed at those meetings; Any e-mails including any attachments or other correspondence between federal government representatives and BC government representatives relating to efforts to negotiate a conservation agreement under s. 11 of the federal Species at Risk Act, SC 2002, c 29 for the Southern Mountain Caribou and their habitat in the SMEA. Exclude any emails or other correspondence or other documents that relate primarily to First Nations and their views about Southern Mountain Caribou and their habitat in the SMEA.
