The calendar of the associate deputy minister — AssocDM - showing dates, locations and times where the AssocDM attended meetings or any other gathering where the AssocDM spoke on or made a presentation on the taxpayer accountability principles in Vancouver; expense claims submitted by the AssocDM for travel related directly or indirectly to the attendance at any meeting where the AssocDM spoke on or did a presentation on the taxpayer accountability principles and, if not included on the expense claim records requested above, the name and position of the person who authorized the travel of the AssocDM for each trip; a copy of any presentation presented by the AssocDM on the taxpayer accountability principles; the number of flights taken by the AssocDM between Vancouver and Victoria and the total cost of these flights a table showing the total number of flights and total cost of the flights would be okay rather than invoices for each flight. (Date Range for Record Search: From 11/01/2013 To 11/30/2015)
