All electronic correspondence, including e-mail, Slack message logs, SMS messages and Blackberry PIN messages, sent by or to the Premier, Deputy Minister to the Premier, Finance Minister or Deputy Minister about foreign ownership/purchases in the housing market or the proposal for a tax on foreign buyers. (Date Range for Record Search: From 07/18/2016 To 08/01/2016)
