Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Finance. Your request is for:

List of all property sales in BC including sales price and address or locality. (Date Range for Record Search: From 03/01/2016 To 05/01/2016)

Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to section 21 (Disclosure harmful to business interests of a third party) of FOIPPA. A complete copy of FOIPPA is available online at:

Section 21(2) of FOIPPA prohibits the release of information which would identify individual taxpayers. Additionally, Section 32(d) of the *Property Transfer Tax Act* allows for information collected under that Act to be disclosed only as part of a "compilation of statistical information." The ministry has determined that information from jurisdictions in which 5 or fewer sales were recorded in a given month cannot be disclosed as it may identify individual taxpayers and does not represent a compilation of statistical information.

Your file is now closed.
