All financial records regarding any money paid to MLA Linda Larson by the Government of BC, relating to her MLA role as well as any other role/title/portfolio she assumes. (Date Range for Record Search: From 05/01/2013 To 01/24/2017)

Please note that although the request states, "...any money **paid** to MLA Linda Larson...", the records actually deal with money that was **reimbursed** to Linda Larson. Please find enclosed a copy of the records located in response to your request. Some information has been withheld pursuant to sections 15 (Disclosure harmful to law enforcement), 17 (Disclosure harmful to the financial or economic interests of a public body), and 21 (Disclosure harmful to business interests of a third party), and 22 (Disclosure harmful to personal privacy) of FOIPPA.
