Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Finance. Your request is for:

A copy of any documents which contain data, discussion, or research which provide information in respect to the cost of replacing the medical services that resident physicians provide to the public or which would otherwise provide information as to the value of medical services provided by resident physicians; In reference to the collective agreement with PAR-BC, section 21.01 which sets out wage rates, the Economic Stability Dividends paid per resident physician under this agreement from April 1, 2013 to date [February 24, 2017].

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety.

Your request was sent to the Ministry of Health which has determined they have no responsive records. The Public Sector Employers' Council Secretariat has provided the attached responsive records, and would like to add that they are not the direct funder to bargaining units, but rather provide high-level figures to the Treasury Board Staff who work with the Ministries responsible to set overall budget allocations. At the time of the first Economic Stability Dividend (ESD), PSEC Secretariat did an estimate calculation for the PAR-BC group, and that estimate put the annual amount of ESD to be \$317 per FTE based on a 0.45% ESD on an annual basis. No bargaining unit level estimate was done for this group for the second ESD.
