**Re: Request for Access to Records**  
***Freedom of Information and Protection of Privacy Act (FOIPPA)***

I am writing further to your requests received by the Ministry of Finance. Please find enclosed copies of the records located in response to the following requests:

- FIN-2017-71795 A copy of the records disclosed for FOI file CTZ-2013-00167, which was a request for: All records contained in previously released JTI-2013-00066. JTI-2013-00066 was for: Information about the Kitimat oil refinery proposed by Mr. David Black; Any records in government about the proposal; The cost of the Navigant Consulting Report on the issue; Any documents related to Premier Christy Clark's ministerial statement on the issue on March 7 in the legislature. The timeframe is August 1, 2012 to March 19, 2013.
- FIN-2017-71796 A copy of the records disclosed for FOI file CTZ-2014-00024, which was a request for: The following materials that are displayed by CLIFF Number and Title/Issue in CTZ-2013-00246: 98319, 98340, 98351, 98363, 98372, 98425, 98430, 98442, 98461, 98467, 98471 and 98495.
- FIN-2017-71813 A copy of the records disclosed for FOI file FIN-2013-00137, which was a request for: Documents (briefing notes, background information, emails) created for or by senior executives for the Minister, DM or ADMs about the potential sale of financial instruments as part of the government's surplus asset sale; Background explanations and/or analysis that supports what the Vancouver Sun reported on February 28, 2013 that Finance Minister Mike de Jong confirmed his government plans to make about \$125 million from the sale of various financial assets in the coming year. Timeframe is January 1, 2013 to March 31, 2013.

- FIN-2017-71815 A copy of the records disclosed for FOI file FIN-2016-61783, which was a request for: Any briefing notes and correspondence from the office of the Minister, Deputy Minister, Assistant Deputy Minister, and Executive Director about the following topics: Affordability, regulation and taxation of housing; Immigration, investment and tourism from mainland China; Real Estate Council/Board investigation of New Coast Realty, Vancouver Police/Richmond RCMP criminal investigation of New Coast Realty, "shadow flipping," money laundering, tax evasion and suspicious or unusual patterns of gambling - All in the context of the Vancouver housing market (Date Range for Record Search: From 04/01/2016 To 04/14/2016)
- FIN-2017-71900 A copy of the records disclosed for FOI file OOP-2012-00306, which was a request for: Any and all correspondence including emails and the contents of attached files on the topic of the Canada-European Comprehensive Economic and Trade Agreement. Timeframe June 1, 2011 to [May 6, 2012].
- FIN-2017-71902 A copy of the records disclosed for FOI file OOP-2013-00804, which was a request for: All correspondence received by the Office of the Premier including the Intergovernmental Relations Secretariat related to the Northern Gateway Pipeline, in particular the equivalency agreement. Timeframe is May 15 to November 27, 2013.


