I am writing further to your request received by the Ministry of Finance. Your request is for:

The annual fiscal year total provincial government expenditure data on the following: The amount for Infirm Dependents Age 18 or Older; Disability Tax Credit. (Date Range for Record Search: From 04/01/1999 To 03/31/2018)

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety.

The Ministry of Finance has stated that the Canada Revenue Agency (CRA) administers the BC *Income Tax Act*, on behalf of the Province of British Columbia. The CRA collects processes and audits the individual tax returns that are filed for each calendar year and provides reporting and information back to the Province. The tax credit information is collected annually on the tax returns; therefore, the figures provided are listed in calendar year format, not fiscal year format as requested.

The figures are based on information the Income Taxation Branch received from the CRA at a particular point in time. At this time, the Income Taxation Branch has not received figures for the 2016 or 2017 taxation years. Please be advised that the provided figures may change based on appeals, or adjustments made by the CRA. Should you require more current figures, the Income Taxation Branch recommends that you contact the CRA.
