A copy of the prospectuses and/or copy of the term sheet for each of the BC Provincial Panda Bonds issued in China specifically including terms and conditions, where the proceeds were invested and what were the parameters for investments; A copy of the last provided statements which show the current investment portfolio of how the money/proceeds are invested, copy of any other statements with the Bank of China and HSBC, and the performance to date from the proceeds of the Panda Bond; Records indicating who are the members of the syndicate involved in selling the bond, including fees or compensation for those syndicate members. (Date Range for Record Search: From 10/01/2017 To 09/24/2018)
