Re: Request for Access to Records Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Forests, Lands and Natural Resource Operations. Your request is for:

Relating to the concrete ramp constructed into the Thompson River at the site located east of Lytton, BC, more specifically between the Canadian Pacific Railway tracks at the junction of the Nicomen River with the Thompson River, just above the start of the main rapids in the Thompson Canyon (the "Ramp"): all records including the original and any amended or additional applications for the permit granted in approximately 2006 for the construction and existence of the Ramp; the documents relating to the due diligence and analysis relating to the decision to grant the Ramp permit; any terms and conditions of the Ramp permit; all correspondence related to the application and granting of the Ramp permit; the Ramp permit; and any amendments to the permit since it was granted and the correspondence. Date range is 2005 to 2006.
