I am writing further to your request received by the Ministry of Forests, Lands and Natural Resource Operations. Your request is for:

All records related to reduced revenues to the Crown by virtue of the stumpage appraisal system regarding timber harvesting operations due to allowing expenses for site preparation, harvesting costs, barging costs, replanting of trees, road construction, road maintenance, and maintenance of booming grounds, including can buoys and anchors and aids to navigation with respect to the road presently known as the Clapp Basin Road, which begins at the Rennell Sound mainline, transverses District Lots 30 and 31, Queen Charlotte District, Graham Island, Haida Gwaii and terminates at the Clapp Basin Recreation site in the Shields bay area: From January 1 1960 to April 26 1980 relating to Q.C. Timber Ltd incorporation # BC0036218 and CIPA Lumber Co. Ltd. incorporation # BC0079341, and, from April 26, 1980 to December 16, 1986 relating to CIPA Industries Ltd incorporation # BC0208847. (Date Range for Record Search: From 01/01/1960 To 12/16/1986)
