Regarding a section of a forest service road called variously Chilcotin South Forest Service Road, or "South Chilcotin Forest F.D.R., also known as a Class 3 Road minimum clearance width 70', passing through Toosey Indian Reserves No. 1 and No. 1A, starting approximately 10 km south of Riske Cree: All engineering drawings, design drawings, and other documents containing the words 'record drawings', 'as built', 'as constructed', 'cross section drawing sheets', 'excavation' and any other related documents prepared by and for road engineers who designed and built the Chilcotin South Forest Service Road; Copies of the B.C. Forest Service Engineering Division Plan VIII-1-26 and Plan IV-7-24. (Date Range for Record Search: From 01/01/1960 To 12/31/1970)
