Re: Request for Access to Records
Freedom of Information and Protection of Privacy Act (FOIPPA)

I am writing further to your request received by the Ministry of Forests, Lands and Natural Resource Operations. Your request is for:

Reports and technical studies, including reports arising from compliance investigations, relating to the cause of the flood that occurred on Cook Creek near Enderby on May 2, 2014, but excluding underlying investigation materials like photos, field notes, interviews. Reports that comments on things like: 1. When the culvert had last been inspected, and by whom (name of responsible company/outfit, not individual) 2. The mechanism that caused the failure of the culvert (e.g., deliberate blockage with logs, rocks, or whatever it was) 3. The approximate time when the culvert became blocked / interfered with 4. The particular offence being investigated (e.g., section 93(2)(b) of the Water Act, section 93(2)(q) of the Water Act, section 94(g) of the Water Act) (Date Range for Record Search: From 05/02/2014 To 02/12/2016)

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety. Your file is now closed.

These records will be published on the BC Government's Open Information website a minimum of 72 hours after electronic release or a minimum of five business days after release by mail in hardcopy.
