Supporting documents for the Victoria International Marina's plan for a floating Marina and building submitted to the Ministry. (Date Range for Record Search: From 12/01/2014 To 01/31/2015)

Please find enclosed a copy of the records located in response to your request. These records are provided to you in their entirety.

The records indicate that during the time-frame specified there was only one supporting document submitted by Community Marine Concepts for the floating marina plan.

The Ministry advises it should be noted that although the plan received wide-spread media coverage, FLNR never approved the proposed change and the approved plan for the marina remains as per the Interim License of Occupation.
