I am writing further to your request received by the Ministry of Forests, Lands and Natural Resource Operations. You narrowed your request on August 12, 2016 through conversation and/or email with Tyler Barbon. Your request is for:

*All documents including plans, reports, documents, notes, inspection records, records of discussion, data, maps, images, correspondence, receipts, records of disbursements, records of payments or other records related to the Old Pemberton Trail/Pemberton Trail that went through the Squamish, Whistler and Pemberton areas in British Columbia. Specifically, records regarding the historical use and travel on the trail and public expenditures related to the trail. The trail may also be known as the "Lillooet-Burrard Inlet Trail" or the "cattle trail" from Lillooet or Pemberton Meadows to the Howe Sound, the Burrard Inlet or Brackendale.*
