I am writing further to your request received by the Ministry of Forests, Lands and Natural Resource Operations. Your request is for:

All records, including but not limited to maps, shapefiles, decisions, briefing notes, information notes, and assessments, regarding the Province of British Columbia's initial decision to add the asserted traditional territory of Skii Km Lax Ha (sometimes known as the Skii Km Lax Ha Nation, Tsetsaut/Skii Km Lax Ha Nation and/or Tsetsaut Consultation Society) to the First Nations Consultative Areas Database; Rejection of the boundary extension of this same asserted traditional territory in this same database, prior to the subsequent decision to extend the boundary; Decision in approximately April to August 2015 to extend the boundary of this same asserted traditional territory in this same database. (Date Range for Record Search: From 01/01/2000 To 03/23/2017)
