We do not have documentation specific to the SBSdk-fresh yield curve. However, documentation of how managed stand yield curves were constructed is already provided in the Updated Data Package (see link in our response immediately below), using the MHmm2-dry yield curve as an example. Refer to page 37, paragraph starting “The following process is used for MSAU yield curve generation...” A directly comparable approach was used for SBSdk-fresh.
