I am writing further to your request received by the Ministry of Forests, Lands and Natural Resource Operations. Your request is for:

*Regarding the history of the highway through District Lots DL 2808 and DL 1589, east of Merritt: Copies of any records relating to any acquisitions or legalization of road tenure including any agreements with past-owners; Any records which show how the road came to be on its current alignment; Any records which show the history and legal status of any historical alignments; Copies of any agreements or plans which resulted from the province attempting to regularize title to the highway in the 1990's; Any documents which relate to the dam at Corbett Lake and the issuance of Water Licenses for Corbett Lake. (Date Range for Record Search: From 01/01/1900 To 03/21/2017)*
