I am writing further to your request received by the Ministry of Forests, Lands, Natural Resource Operations and Rural Development. Your request is for:

Records held by the Ministry regarding camping on Crown Land along the banks of the Kitimat River and recreational fishing on the Kitimat River, specifically: Communications between the Ministry and the District of Kitimat; Communications and considerations between the Ministry and other stakeholders along the Kitimat River including but not limited to Alan/Rio Tinto Alcan/Rio Tinto, LNG Canada and the Haisla Nation as those communications relate to camping, pollution or fish in the river; Complaints from the public, fishing guides, private businesses and others about the state of the Kitimat River due to camping and fishing; In addition, the Ministry's response to the flash flooding on the Kitimat River in September 2017 and any communications with other agencies including Kitimat on the flooding and the short term and long term consequences of that flash flood.
