*The number of estimated annual extraction from each of the following company's aggregate quarries, as well as the number estimate of total mineable reserves over the life of each company's mine (as found in their annual reports submitted to the Ministry): Mainland Sand & Gravel - mother company is Summit Materials, Lehigh Materials, Fraser Valley Aggregates, Lafarge, Valley Gravel, and any other quarry/pit that is located or operates in the B.C. lower mainland (that is, a region bounded in the North by Port Coquitlam, South by White Rock, West by Vancouver and Richmond, and East by Chilliwack). (Date Range for Record Search: From 01/01/2010 To 10/25/2017)*
