Furthermore, upon submission of the records the Ministry made note of the following; there is very little documentation to provide. 3 of the 5 disposition numbers provided for 0214338 have no documents yet. We have 1-page docs for 2 of the dispositions listed for 0214338. The disposition #s for 8014369 are the same and are for the replacement application which was cancelled so no document was ever created. Doc #R178005 listed has a 2-page document on file and File #0307383 is an inventory file so there is no tenure document.
