I am writing further to your request received by the Ministry of Forests, Lands, Natural Resource Operations and Rural Development. Your request is for:

*Regarding structure protection units (SPU) and structure protection crews (SPC): any and all records, including emails that reflect deployment of SPUs and crews from BX Swan Lake; breakdown of fees paid for fire department and contractors (annual aggregate for each – if able to be split out into crew vs equipment rates would like that level of detail; if able to split into regions would like that level of detail) including, detail of municipal fire departments that have submitted and have expenses reimbursed for deployment within their own fire protection areas (Date Range for Record Search: From 01/01/2016 To 11/13/2018)*
