I am writing further to your request received by the Ministry of Forests, Lands, Natural Resource Operations and Rural Development. Your request is for:

Records relating to flood conditions in the Thompson-Nicola region, near Merritt, including any records or information regarding lake elevations or seasonal flooding in that region during the spring of 1948, specifically, the surface elevation in 1948 of Stoney Lake and Minnie Lake, both located on the land of the Douglas Lake Cattle Company - other lakes of interest would Pennask Lake, Douglas Lake or Nicola Lake. (Date Range for Record Search: From 01/01/1948 To 08/31/1948)
