Records indicating how much money is being spent on maintenance on the Domano FSR per calendar or fiscal year - from the gate entrance at the City of Prince George to West Lake – including but not limited to: snow plow costs, gravel costs, employee costs - to do the work, if not contracted out, and grading costs; The total original cost to install this Forest Service Road in around approximately 1991-1992. (Date Range for Record Search: From 01/01/2014 To 03/15/2019)
