The Ministry has also advised that the *1304628 – Pre-Tantalus Reserve/Notation – Disp Trans SID # 116147* file is extremely old and there is no information on commencement date of expiry, but it expired before 1999 when the Lands system was populated. Dominion Patents, as this file may provide you with the information you are requesting, including the file SID#116147.


