Copies of the following Lands "O" files, currently held at GEO BC, 3400 Davidson Ave, Victoria, (and all their associated folders/volumes): O 28428; O 47792; O 26076 (Date Range for Record Search: From 1/1/1912 To 1/1/1950)

The records located in response to your request will be delivered through the BC Secure File Transfer Service. Separate emails will follow from the BC SFT Notification Service directing you how to set up an account and where to obtain your records. Some information has been withheld pursuant to section 22 (Disclosure harmful to personal privacy) of FOIPPA. A complete copy of FOIPPA is available online at:

We have provided you with the best available copy, although you may find that some pages are in poor condition. As mentioned in an email on January 2, 2020, "O" file # O 28428 is either missing or destroyed as it was not available for microfilming in 1952.
