Copies of: Any and all records dated Jan. 1, 1900 to December 31, 1956 concerning irrigation systems owned or operated by: British Columbia Fruitlands Company; British Columbia Fruit Lands Company; British Columbia Fruitlands Irrigation and Power Company; British Columbia Fruit Lands Irrigation and Power Company; and/or B.C. Fruitlands Irrigation District. Copies of: Any and all records that reference a petition, made in or about 1946, to the BC Provincial Government concerning the irrigation system owned or operated by one of the above entities; and Any and all records that reference the "Noble Creek Irrigation System" or the "Noble Creek Water Users" from Jan. 1, 1900 to December 31, 1973. (Date Range for Record Search: From 1/1/1900 To 12/31/1973)

The records located in response to your request will be delivered through the BC Secure File Transfer Service.
