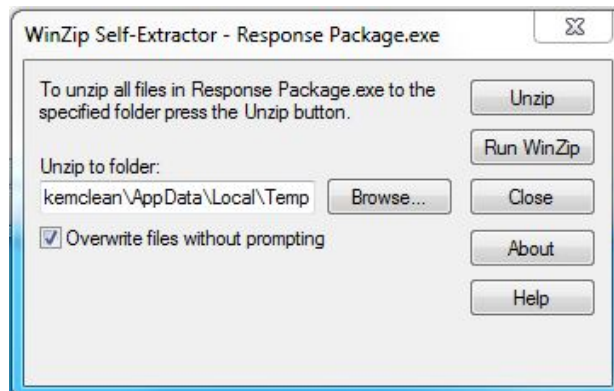

How to Get Your Password Protected Records

ATTENTION: The following process results in a copy of your FOI response package being copied from the CD to the computer being used to access your response package. To ensure the protection of your privacy IAO does not recommend using a public computer to view your response package.

1. Insert the CD provided into the CD drive of your computer.
2. Select "Open folder to view files". Otherwise, navigate to your CD drive.
3. Double click on the zipped file on the CD: 
4. Click "Browse," select a location to save your file, select "Unzip".



5. You will be prompted for a password.
6. Enter the password previously provided
7. Once you have entered the password you will not have to re-enter a password for the file that has been moved from the CD to the location where you saved the file on your computer. The file on the CD will still be password protected.
